Directions from A5 (Stony Stratford):

Come off at the second exit and turn left onto the A509 H5 'Portway'. At the first roundabout take the third exit on to the V6 'Grafton Gate'. Take the first left turning on to Silbury Boulevard. Take the third right turning this brings you to Upper Fourth Street, continue halfway down Upper Fourth Street, there is a right hand turning leading down a ramp with a set of 'traffic lights' at the bottom. You need to leave your car and enter the offices to retrieve the card that will allow you access to the Square. The office is 2nd building on the right from the barrier.

Directions from A421 (Buckingham) :

Continue on the A421 H8 'Standing Way'. At the 6th roundabout 'Bleak Hall' turn left onto V6 'Grafton Street', continue over two roundabouts onto 'Grafton Gate', continue over three small roundabouts. At the third roundabout take the third exit on to Silbury Boulevard, take the third right turning this brings you to Upper Fourth Street, continue halfway down Upper Fourth Street, there is a right hand turning leading down a ramp with a set of 'traffic lights' at the bottom, You need to leave your car and enter the offices to retrieve the card that will allow you access to the Square. The office is 2nd building on the right from the barrier.

Directions from A422 (Newport Pagnell):

From A422 you will join the H3 'Monks Way' at the 5th roundabout 'Bancroft'. Take the first exit on to the V6 'Grafton Street', continue over two roundabouts until you join V6 'Grafton Gate'. At the small roundabout take the left turning on to Silbury Boulevard. Take the third right turning this brings you to Upper Fourth Street, continue halfway down Upper Fourth Street, there is a right hand turning leading down a ramp with a set of 'traffic lights' at the bottom. You need to leave your car and enter the offices to retrieve the card that will allow you access to the Square. The office is 2nd building on the right from the barrier.

Directions from A42 (Bedford):

From the A421 you will join the H8 S ending Way'. At the 2nd roundabout 'Kents Hill', take the third exit on to V10 'Brickhill Street', continue straight, at the 2nd roundabout 'Woolstone' take the left turn onto H6 'Childs Way'. At the 7th roundabout take the third exit on to the V6 'Grafton Gate', At the third small roundabout take the third exit on to Silbury Boulevard. Take the third right turning this brings you to Upper Fourth Street. Continue halfway down Upper Fourth Street there is a right hand turning leading down a ramp with a set of 'traffic lights' at the bottom. You need to leave your car and enter the offices to retrieve the card that will allow you access to the Square. The office is 2nd building on the right from the barrier.

Directions from M1:

Come off at Junction 14, take the left turn onto A509, at first roundabout take the third exit on to the H5 'Portway', Continue straight, at the eighth roundabout 'North Witan' roundabout take the first left onto Witan Gate. At the traffic lights turn right, on to Silbury Boulevard, take the first exit on the left, this brings you to Upper Fourth Street, continue halfway down Upper Fourth Street there is a right hand turning leading down a ramp with a set of 'traffic lights' at the bottom. You need to leave your car and enter the offices to retrieve the card that will allow you access to the Square. The office is the 2nd building on the right from the barrier.
